# YOU MAY BE WONDERING...

All residents should have recently received several updated ordinances by mail. You may be wondering what these are and why the Commission made these changes. Some changes were made as part of the update to ordinances during the revisions that began in 2014 (state law requires cities to revise ordinances every five years). Additionally, the Commission also recently voted to place Bancroft Lane back under the Maintenance Department and create a new department -Community Outreach. This means the Commissioner for Maintenance, Bryan Berman, will also be responsible for Bancroft Lane. Commissioner Matt Tungate will be the Commissioner in charge of the Community Outreach Department including dissemination of public information, creation and maintenance of a city website and preparation and organization of events hosted by the city. Additionally, after the revision process is complete, we plan on making the ordinances available to all citizens on our new website in .pdf format.
