Please be aware that MSD is proceeding with their plans and beginning work on a new pump station in Bancroft. A light post off of Old Orchard Court had to be removed before the blasting could begin. We are not currently aware of the new blasting schedule but it is predicted to go on for about 60 days weather permitting. Some blasting will be for a pipeline in the woods and some will be at the old Wastewater Plant. Please do not be alarmed by the sound of the blasting.
