November Notes from the Mayor

Please consider joining us for our next Commission meeting, Thursday, Nov. 14 at 7 p.m. We will be moving forward with the first reading of a new ordinance dealing with abatement and decontamination of properties that have been subject to meth contamination. We will also discuss the revision of a second ordinance with the city's building permit process. This is a process we get a lot of questions about and are working to clarifying the requirements.

For Approval: "Ordinance No. 5 Series 2019, An Ordinance Enacting Chapter 152 Abatement and Decontamination of Properties Subject to Methamphetamine Contamination Notice; Lien."

The 2019 Kentucky legislature passed <u>Senate Bill 89 (SB89)</u> allowing cities to enact an ordinance to deal with homes contaminated by the chemicals involved in the production of the illegal drug methamphetamine. If the city enacts an ordinance adopting the provisions of SB89, the city can decontaminate the home and seek reimbursement of the costs by placing a lien on the home if necessary. While it is highly unlikely we will have to deal with such a circumstance, we cannot assume it could not happen. This ordinance could at some time in the future help the city recoup the costs of this specific type of nuisance abatement.

For Revision: City Ordinance 150.03

The revised ordinance involves the building permit process. City Ordinance 150.03 requires residents to obtain permission from the City Commission before doing any construction on their property. These types of construction requests typically involve fences, sheds, patios, and pools. We currently have an informal process for obtaining permission for construction. The ordinance revision will allow the Commission to establish a more formal permit process for construction requests. At the October Commission meeting, we discussed a potential permit process. Our goal is to allow us to better track construction requests, not to make the process more difficult to obtain permission for construction.

IT Upgrades

Also, at the November City Commission meeting, we plan to meet with our email and website service provider to discuss potential upgrades in IT services and IT security. While we have had no major issues with IT security it is important that we make sure everything is being done to safely secure our IT services.

Jack Frost Knocking on the Door

As winter weather approaches, we want to remind you that in the event of severe weather like snow or ice storms, the city will treat the roads and remove snow when it reaches approximately 3 inches. Priority is placed on hills. If there is the prediction of heavy snow, we ask that you do not park on the roads so we can more easily and completely clear the road of snow and ice. This is not required by ordinance, but your cooperation is appreciated.

For your safety, please call 911 or 311 to have police dispatched. If Chief Yeager is working, then they will dispatch him to help you, otherwise, they will dispatch a Metro police officer. Do not personally seek out Chief Yeager to get assistance for an emergency.

CRIME PREVENTION

Chief Yeager works hard to keep Bancroft safe. Here are a few of his simple crime prevention tips.

- Turn on your porch lights and exterior lights at night.
- Keep your doors locked, even in the daytime.
- Lock your car doors and remove valuables from your cars, even if locked.
- Keep your garage door closed, especially at night.
- If you see something suspicious, then say something.
- Call 911 if you see a prowler.
