# **December Notes from the Mayor**

At the December City Commission meeting, city commissioners will again address issues residents have been experiencing with Anytime Waste Systems. We know there has been considerable frustration with the trash services provided by Anytime. Some residents have been very vocal with their complaints on Facebook. We, the City Commission members, share your frustrations. We have been working and continue to work toward making sure we have quality trash removal services. While residents have the opportunity to complain on Facebook, City Commissioners are not able to do so without compromising our efforts to make sure we receive the trash services we are supposed to receive. That does not mean we are ignoring your concerns. Your concerns are our concerns, but we must address our concerns during City Commission meetings, not on Facebook.

We plan to discuss recent problems with Anytime at next week's commission meeting. This is just one step in our ongoing efforts to resolve the issues consistent with the best interests of us, the Bancroft residents. If you have concerns or would like an update on the situation, we hope you will join us Thursday, Dec. 12 at 7 p.m. As always, Bancroft residents are welcome to attend the City Commission meetings. Your input is very important to this process.

The City Commission is working on other items of business, including: a meth house abatement ordinance, a revision to the Building ordinance allowing a more formal building permit process, review of our city IT services with the contractor, developing city personnel policies, and holiday decorations.

Congratulations to Commissioners Jaimie Schapker and Paul Chumbley on their election to the City Commission for 2020. Both were appointed as commissioners in January 2019 and were required to stand for election to serve the second year of the standard two-year term. They take the oath of office as elected commissioners at the December meeting.

### **CRIME PREVENTION**

Chief Yeager works hard to keep Bancroft safe. Here are a few of his simple crime prevention tips.

- Turn on your porch lights and exterior lights at night.
- Keep your doors locked, even in the daytime.
- Lock your car doors and remove valuables from your cars, even if locked.

 Call our police line at (502) 263-3663. Leave a voicemail with your name and phone number. Chief Yeager will call you back when he is on-duty.

For your safety, please call 911 or 311 to have police dispatched. If Chief Yeager is working, then they will dispatch him to help you, otherwise, they will dispatch a Metro police officer. Do not personally seek out Chief Yeager to get assistance for an emergency.

- Keep your garage door closed, especially at night.
- If you see something suspicious, then say something.
- Call 911 if you see a prowler.
