# **Notes from the Mayor**

I want to start my comments with very good news. The police cruiser is back from repair of the transmission. As I mentioned last month, this was a warranty repair. Chief Mudd will continue to periodically do bike patrol. A special thank you to Chief Mudd for spending many more hours than normal patrolling on his police bike in hot weather while the cruiser was in for repair.

Last month we approved a Bancroft Police Department Standard Operating Procedures (SOP) to replace the previous SOP that was outdated. This month we are seeking the city commission's approval to add new sections to the SOP addressing specific issues not included in the previously approved SOP. All the SOP additions are based on the Kentucky League of Cities (KLC) model law

enforcement policies.

You will see on the September 2021 City Commission meeting agenda a new business item to revise the current budget. Didn't we just approve a new budget? Yes, we did, but we received \$66,293.50 in American Rescue Plan (ARP) federal funding after we passed the FY 2021-2022 budget, so we must now revise the budget to reflect the additional revenue and add an expense line in the budget to allow for the expenditure of some of these funds for approved uses during this fiscal year.

The development of the Bancroft Facebook group page about six years ago has been a wonderful benefit for Bancroft residents as a community forum and a place for the city commission to disseminate information quickly to everyone in the city who has signed up. For everyone to continue to enjoy the group page, we realized it was time for us to adopt a revised set of community guidelines for its use. At the September meeting, we will be reviewing a proposed set of community guidelines developed by Commissioner Schapker, who is the group administrator. If you are not already on the Bancroft Facebook group, I encourage you to join. The group is intended for exclusive use by Bancroft residents.

# **Notes from Chief Mudd**

I have been flagged down a few times in recent weeks regarding street parking in the City of Bancroft. This is covered in Chapter 72 of our city ordinances, and while I'm not going to go over all the information contained within this chapter, I would like to mention a couple of things.

The complaints I've received are primarily about parking that creates an obstruction or hindrance to the flow of traffic on one of our city streets. I've generally observed these near intersections where a vehicle is parked such that turning from one street to another is blocked and causes a vehicle to have to go into the oncoming lane or wait until a car turns from the said lane in order to

proceed.

Parking within 30 feet upon the approach to a stop sign is prohibited, but I would suggest not parking on the other side of this approach either as it creates the situation described above.

Another situation that can create an obstruction or hindrance is when people park directly opposite one another on either side of the street. In my opinion, it is dangerous as it divides the driver's attention as they proceed between the vehicles. This means they could potentially miss a child coming from behind a vehicle on one side or the other. It also has much more potential for mirrors to be knocked off or otherwise damaged.

The one violation I have observed most often is people parking with the left side of the vehicle next to the curb or facing against traffic. This is covered in Chapter 72.02 (A) of our parking ordinance. Just so everyone is aware, this is how I handle such violations. If it is a vendor of some kind, such as landscapers,

plumbers, electricians, etc., I generally allow them to do so as most times it is simply necessary for them to park in such a fashion in order to best complete their job.

If it is a regular vehicle, I will note the time and allow an hour before leaving a courtesy notice on the windshield. Most visitors probably aren't familiar with our ordinance and even residents may not be aware until it is pointed out to them.

For your safety, please call 911 or 311 to have police dispatched. If Chief Mudd is working, then they will dispatch him to help you, otherwise, they will dispatch a Metro police officer. Do not personally seek out Chief Mudd to get assistance for an emergency.
