**BANCROFT CITY COMMISSION**  
**REVIEWS ARPA-FUNDED LIGHTING STUDY**

The Bancroft City Commission is currently reviewing a comprehensive lighting study made possible by American Rescue Plan Act (ARPA) funding. This initiative, aimed at enhancing our city's lighting infrastructure, has been completed and the commission is now carefully considering the recommendations.

As part of this ongoing effort, the city is already in the process of upgrading our streetlights. Crews will be working to replace the existing bulbs with energy-

efficient LEDs, which will provide brighter, more sustainable lighting throughout Bancroft. This upgrade is a crucial first step and will be completed before any further decisions are made based on the study's findings.

## **MAYOR'S NOTES**

My appreciation and thanks go out to Commissioners Magers and Berryhill. They are excellent purveyors of city information on our Facebook page. As Commissioner Berryhill said, the commission is moving forward updating our lighting and subsequently looking at the need that might exist to add new lighting.

We are so very fortunate to have a largely incident free city. Much of that goes to our police presence and diligence in controlling good traffic. So much comes from the simple act of observing traffic and discussing possible violations with those who need the talk.

On a personal note, while we do not have an overnight on-street parking ordinance I drive along our streets and see where there are serious “oil” leaks along curbs that have customary overnight parking. Our tax money goes to maintain the streets and it isn’t in-expensive. If one of your cars happens to have a leak and it is commonly parked on the street, please put something under it to protect our roads. I know it will be a hassle, but the next repaving will likely cost us in the range of \$400,000 or more. And, when the cars are gone the appearance of a neighborhood that doesn’t care, and I know we do.

1. Call our police line at **(502) 263-3663**. Leave a voicemail with your name and phone number. Chief Mudd will call you back when he is on duty.

For your safety, please call 911 or 311 to have police dispatched. If Chief Mudd is working, then they will dispatch him to help you, otherwise, they will dispatch a Metro police officer. Do not personally seek out Chief Mudd to get assistance for an emergency.
