## Changes in Commission

We have a new Mayor!

Melissa Dimeny resigned as Mayor of Bancroft as of December 9, 2015. The commission unanimously voted to appoint Commissioner Jeff Magers as the new Mayor for the City of Bancroft. The commission would like to thank Mayor Dimeny for her hard work and her year of service.

## Vacancy on the Commission

There is a current vacancy on the city commission. Any city resident interested in serving on the city commission who meets the statutory requirements to serve in that position, should submit a resume and letter of interest to the city clerk by Wednesday, January 13th. The city commission will interview applicants at the next city commission meeting on January 14th. The resident appointed by the city commission to fill this vacancy will serve the remainder of 2016. The position will be filled for a full term by city-wide election in November 2016.

## Insurance Premium Tax Fees
